



**AGREEMENT TO HOLD HARMLESS
WAIVER AND ASSUMPTION OF RISK**

This document is a legal document. Please read and understand its contents before signing the document.

I, the undersigned, understand that attendance at a Schutzhund training session, trial, seminar or related or other function is not without risk to me, members of my family, my dog or any guests who attend these functions.

I realize the dogs that the above stated persons, others, and/or I may be exposed to may be difficult to control and may cause injury even when handled with the highest level of care and that working with, around, or participating in the training of any dog carries with it the risk of injury.

The undersigned covenants and agrees, to the fullest extent allowed by law, to protect, defend, indemnify, and hold Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank, individually and/or as hereinafter sometimes referred to as "Joliet Schutzhund", any of their employees, officers, members, guests, invitees and/or other agents harmless from all claims or liability of every type (including court costs and/or legal fees) for injury or death to any person or dog, or for damage to property arising out of or relating to the undersigned's participation in and/or attendance at Schutzhund training sessions, trials, seminars or other function as well as to the presence of any other party accompanying the undersigned, under the undersigned's direction or in attendance at the undersigned's request or invitation. This assumption of risk and release of liability, claims, demands and causes of action of every kind and character shall apply even if Joliet Schutzhund, Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank's sole negligence is the cause of such accident, injury, or damages.

By attending and remaining at a Schutzhund training session, trial, seminar or related function, I accept the property and any improvements in an "as is" condition. No warranty has been made to the undersigned as to the existing condition of any of the property. The undersigned understands that dangerous conditions can and may exist on the property. The undersigned understands and affirms that working with dogs can result in serious injury and/or death to the undersigned, others, or dogs. The undersigned assumes, accepts and acknowledges

all responsibility for any dangers, accidents, risks, and hazards associated with the undersigned's attendance at a Schutzhund training session, trial, seminar or related function. Further, the undersigned indemnifies and holds Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank and Joliet Schutzhund, any of their respective family, agents, employees, representatives and guests harmless from claims, demands, causes of action and/or damages, including attorney's fees, resulting from any accident, incident or occurrence arising out of attendance at a Schutzhund training sessions, trial, seminar or related function. If not otherwise covered herein, the above releases and hold harmless also apply to any person or entity upon whose property, Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank and/or Joliet Schutzhund may be holding any activity.

I acknowledge that I have read and understand this document and the attached Training Ground Rules.

In consideration of the attendance of any of my children at any Schutzhund training session, trial, seminar or related function, I hereby release and hold Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank and/or Joliet Schutzhund harmless from any and all claims or suits arising in any way from the child's attendance at and/or participation in a Schutzhund training session, trial, seminar or related function, for any injury to my child or his/her property or his/her death caused by the negligence of Gary Fuqua, Beth Fuqua, Kurt Heinrich, Mary Heinrich and or David Blank and/or Joliet Schutzhund, staff members or other individuals to the fullest extent allowed by law.
